









ENERGY CONSUMPTION



MAXIMUM POWER for dirty floor

If the dirt is stubborn and difficult to remove, the machine delivers more power

MAXIMUM ENDURANCE for maintenance cleaning

When the dirt is lighter, power returns to normal levels thus the battery lasts longer

ENDURANCE (over time)



MAXIMUM POWER

Increased power only when needed



MAXIMUM ENDURANCE

Under normal dirt conditions, the power remains constant, increasing battery endurance


